\_\_\_\_\_ **IN-GROUND.** Affiant states he/she will fence the pool or the entire yard in which such in-ground pool is located with a minimum height of sixty inches (60") with a gate and/or locking device to prevent uncontrolled access by means other than through the gate from the street and from adjacent properties as required by Chapter 303.03 of the Zoning Resolution of Jackson Township.

\_\_\_\_\_ **ABOVE-GROUND.** Affiant states he/she will utilize a 60" or greater fencing barrier and/or a removable and/or lockable ladder device to prevent uncontrolled access by means other than through the gate or ladder from the street and from adjacent properties as required by Chapter 303.03 of the Zoning Resolution of Jackson Township. .

*"Affiant states that the pool is intended to be used primarily for the enjoyment of the occupants of the property and Affiant states that the pool will be used in a safe manner to minimize the risk of injury and to prohibit unauthorized access. Affiant further states that the pool will be properly maintained so as to not become a nuisance especially with regards to controlling the growth of mosquitoes. And, Affiant further agrees to Release and Hold Harmless the Jackson Township Board of Trustees, its employees and assigns including the City of Grove City for any Claim, Loss, Cost or Expense, or any Damage which may be Asserted, Claimed or Recovered against or from the Jackson Township Board of Trustees or Grove City that may result from Affiant's use or misuse of the swimming pool, including such loss as may result from trespassers or persons that otherwise should be prohibited from using the pool."*
