Establish Township 2020 Board Meeting Dates

WHEREAS, the Jackson Township Board of Trustees, in compliance with Ohio Revised Code 121.22 hereby establishes the date, time and place of regular and special meetings of the Board of Trustees, the following schedule is presented.

1. Regular public meeting

Regular public meetings of the Jackson Township Board of Trustees occur twice monthly on every other Tuesday of each month, or as otherwise noted, and will be conducted on the dates and times as listed in the schedule below. An open caucus session prior to the meeting may be conducted for the purpose of reviewing the meeting agenda. All meetings will be held at the Jackson Township Administration Building, 3756 Hoover Road, Grove City, Ohio 43123, unless otherwise changed.

2. Special and emergency meetings

Special and emergency meetings of the Board will be held at the call of any two members of the Board or by the Chairman, specifying the date, time, location and purpose of the meeting. Unless otherwise provided, special meetings will be held at the same location as regular meetings. The public information officer shall give notice of the date, time, location and purpose of a special meeting in the same manner as the posting for notice of regular meeting with notice at least 24 hours prior to the meeting.

3. Notice to news media of special and emergency meetings

News media who have requested notice of special meetings shall be individually notified by the public information officer of the date, time, location and purpose of any such meeting at least 24 hours in advance of the meeting. If the meeting is an emergency meeting, the member or members, calling it shall immediately notify the media who have requested notification of the date, time, location and purposes of the meeting.

4. Special notice required by law

When a particular form or method of notice is required by statute for a public hearing or meeting, notice shall be given in the form and manner prescribed by statute, in addition to notice otherwise required under this resolution, now
