RESOLUTION 2021-007

Mr. Rauck moved to table resolution 2021-007 to open the bids for SCBA Airpacks with Face Pieces. Mr. McClure seconded the motion. VOTE: all yes.

RESOLUTION 2021-008

Mr. Rauck read resolution 2021-008 and moved to advertise for bids for the Diesel Exhaust Removal Systems. Mr. Burris seconded the motion. VOTE: all yes.

RESOLUTION 2021-009

Mr. Rauck read resolution 2021-009 and moved to authorize to hire 3 full-time firefighters. Mr. McClure seconded the motion. VOTE: all yes.
